Chairman’s Report:

- A. Appointment of David Crone to the Prairie Council on Aging board of directors for a term of service commencing on May 1, 2022 to December 31, 2022. Mr. Crone will serve along with Vice-Chairman Gary Krueger in representing the interests of senior citizens in the regional service agency in general, and Jersey County in particular
- B. Reappointment of Rick Deverger to serve on the Nutwood Levee District Board of Trustees. The term of service will be from May 1, 2022 to May 31, 2025.
- C. A bid estimate is being sought to provide a concrete cap to the limestone step in place at the front door entrance of the courthouse to provide a smooth surface and eliminate a liability risk to the County.
- D. The County Board Office has received notice from the Illinois Department of Natural Resources advising that the Grafton Boat Works, located at 400 Front Street in Grafton, Illinois has been entered in the National Register of Historic Places.
- E. Notices are being sent to existing liquor license holders for renewal. The Liquor Control Committee will meet later in May to review applications with recommendations to the County Board for action in June. An individual named Joseph Bullard has advised the County Clerk’s Office he will seek a full license to take effect on July 1, 2022 but would also seek a “special event” license for June 11, 2022. Mr. Bullard seeks to operate a food and beverage concession via a lease he has established with the Illinois Department of Natural Resources for a structure at the harbor at Pere Marquette State Park.
